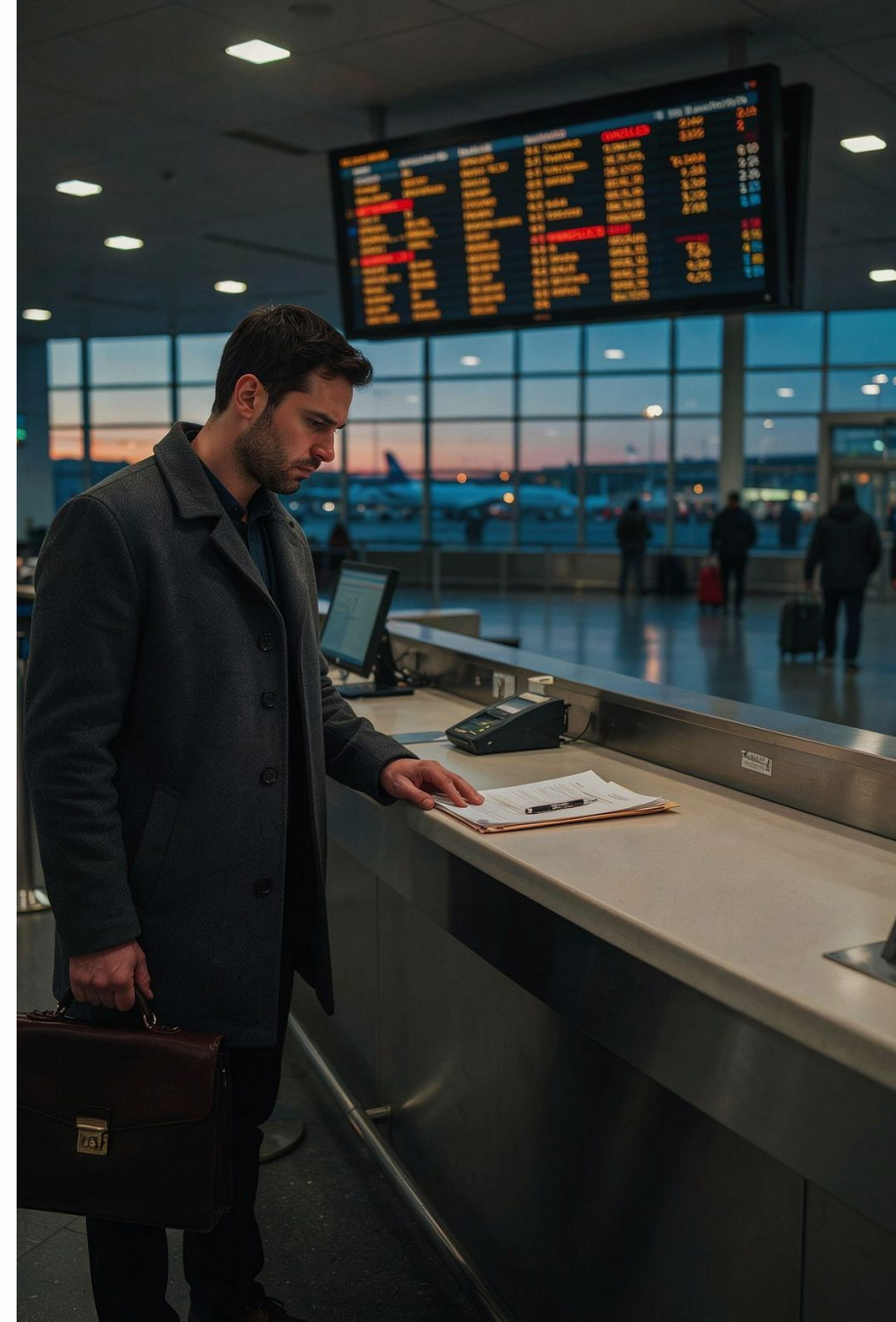

Airlines Owe You More Than You Think

Thousands of Indian passengers lose money daily to sudden cancellations and denied boarding. Under **DGCA Civil Aviation Requirements (CAR)**, you're legally entitled to **cash compensation up to ₹20,000** — on top of a full refund.

The Problem

Airlines push restricted vouchers with expiry dates — not the cash they owe you.

The Law

DGCA CAR mandates direct cash or bank transfer. Vouchers are **not** a legal substitute.

The Power

Know your rights. Refuse vouchers. Demand cash on the spot. Escalate if needed.

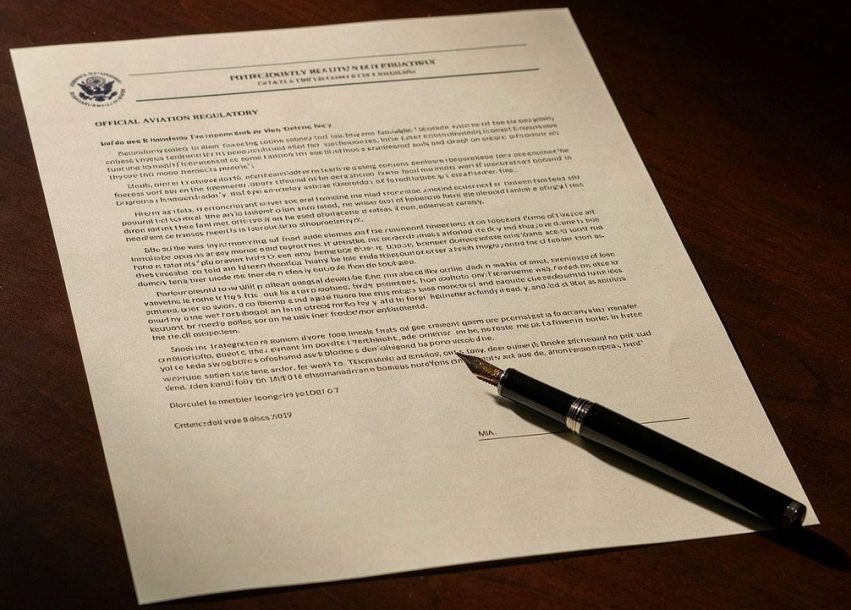
DGCA Compensation: What Airlines Legally Owe You

✗ Flight Cancelled Within 24 Hours

Full refund on unused segment + **₹5,000–₹10,000 cash** based on route distance.

➖ Denied Boarding (Overbooking)

Full refund or alternate flight + **up to ₹20,000 direct cash** based on waiting time.



Cash vs. Voucher: Know the Difference

Airline Voucher

- **Restricted travel credit**
- **Same carrier only**
- **Expiration date**
- **Forfeits cash rights**
- **Zero legal standing**

Legal Cash Rights

- **100% ticket refund**
- **₹5,000–₹20,000 direct cash**
- **Bank transfer or cash in hand**
- **DGCA mandated**
- **Full legal protection**

Why Airlines Push Vouchers

Vouchers cost airlines nothing. They lock you in, expire unused, and **accepting one voids your right to cash compensation.**



Never sign a voucher acceptance form without reading the fine print.

The Voucher Trap — And How to Escape It

1 Vouchers Are Not Legal Tender

DGCA rules require compensation in **cash or bank transfer** — not travel credits.

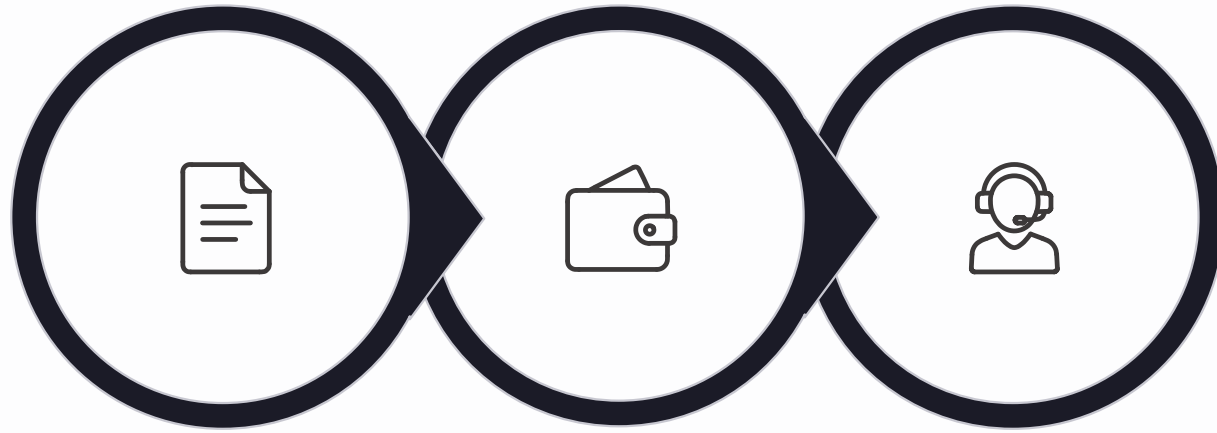
2 Decline. Demand. Done.

Refuse vouchers at the desk. Cite **DGCA Passenger Charter Rules**. Insist on cash or direct bank transfer.



The 3-Step Execution Checklist

Flight cancelled or boarding denied? Do this immediately.



Ask for Proof

Refuse
Vouchers

Escalate on
AirSewa

Follow all three steps in order. Most passengers resolve claims without legal help.

Step-by-Step: Claiming What You're Owed

1

Demand Written Proof

Get a written statement confirming the reason. Invoke **DGCA CAR Section 3, Series M, Part IV** and demand cash compensation on the spot.

2

Refuse All Vouchers

Decline credit shells, coupons, and flight vouchers. Accept only **cash or direct bank transfer**.

3

Escalate via AirSewa

File at **airsewa.gov.in**. Upload your ticket, booking confirmation, and incident details.

AirSewa: Your Escalation Authority

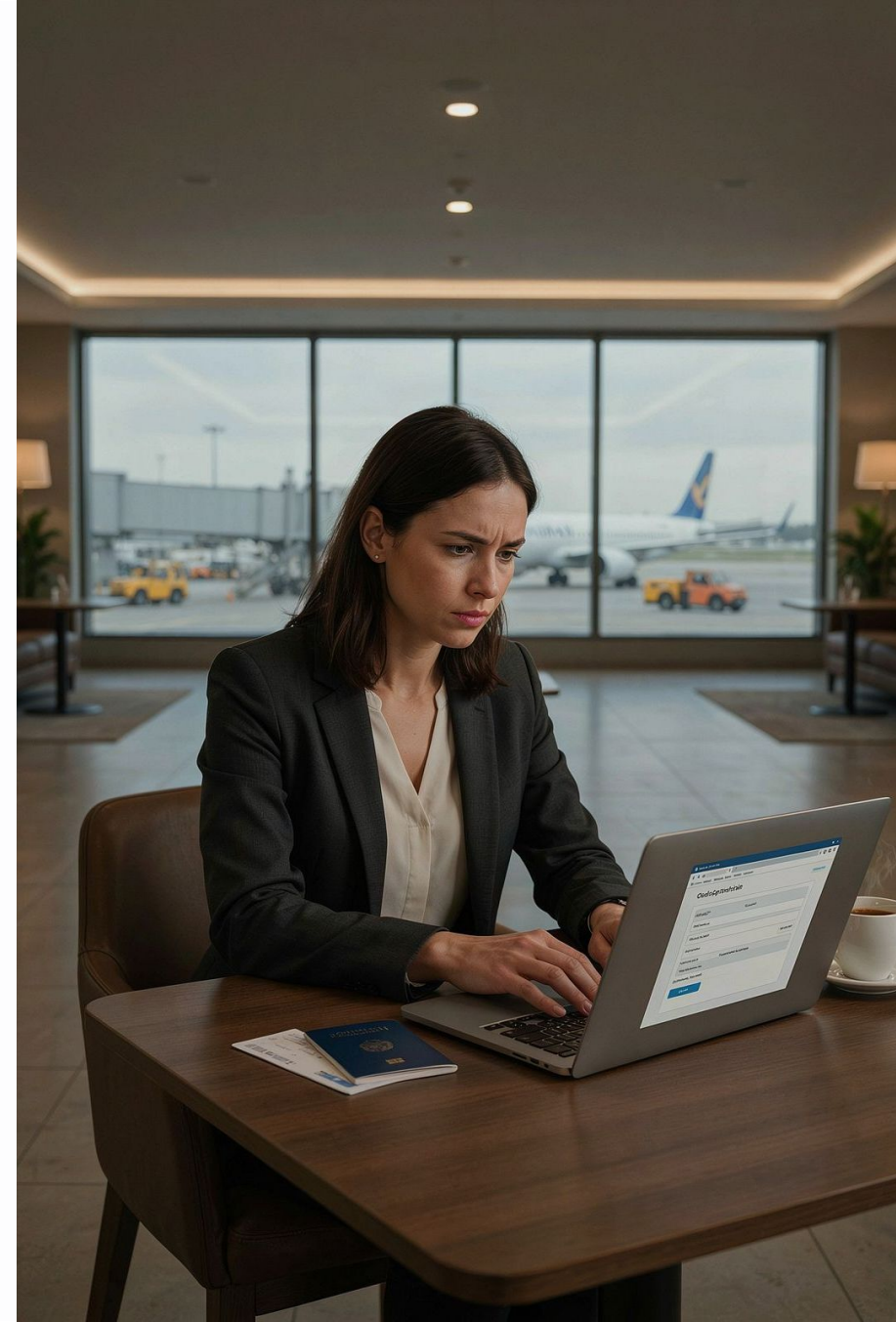
When airlines refuse to pay, file at **airsewa.gov.in** — the Ministry of Civil Aviation's enforcement portal. Government-backed. Free to file. 24/7 access.

Upload These

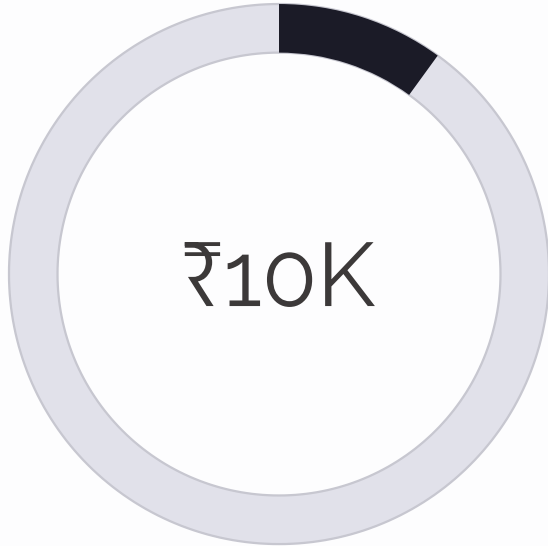
Boarding pass, ticket, booking confirmation, written denial, airline correspondence.

What Happens

DGCA intervenes directly. Airlines must respond within prescribed timelines — with enforcement authority.

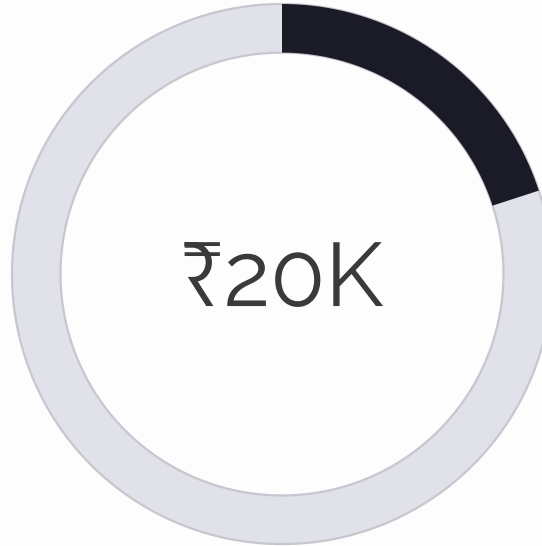

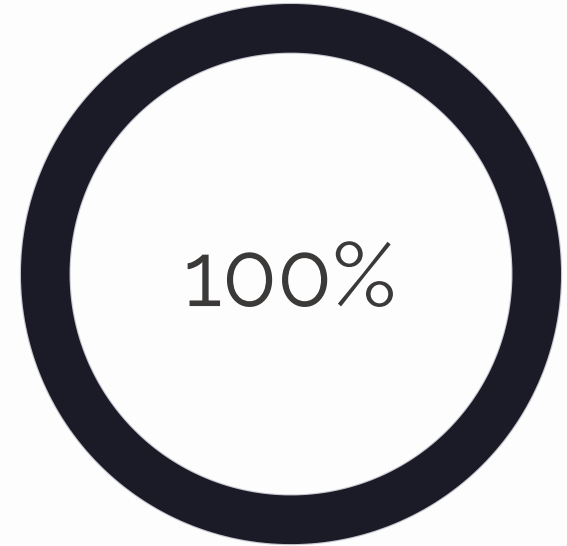
Cancellation Payout

Cash compensation for flights cancelled within 24 hours.



Denied Boarding Max

Maximum cash for overbooking-related denied boarding.



Refund Guaranteed

Full ticket refund is mandatory. Cash compensation is additional.

❏ Never accept a voucher. Cash compensation is non-negotiable under the DGCA Passenger Charter.
